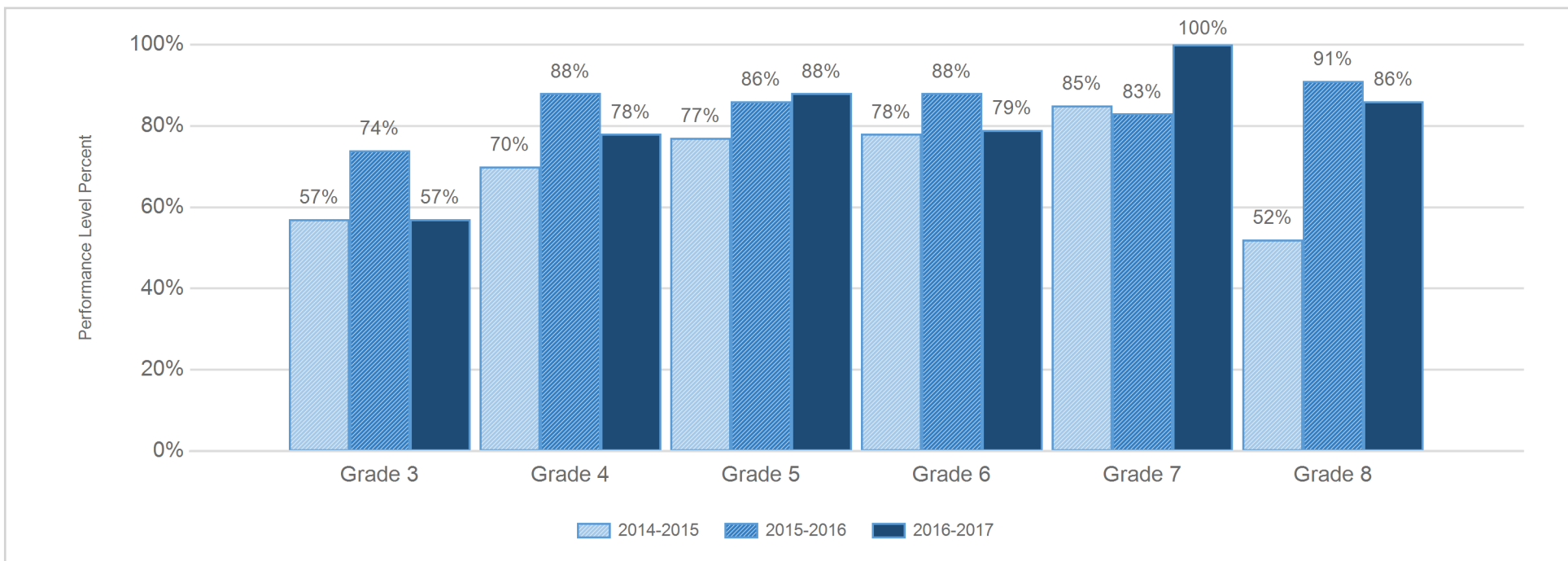

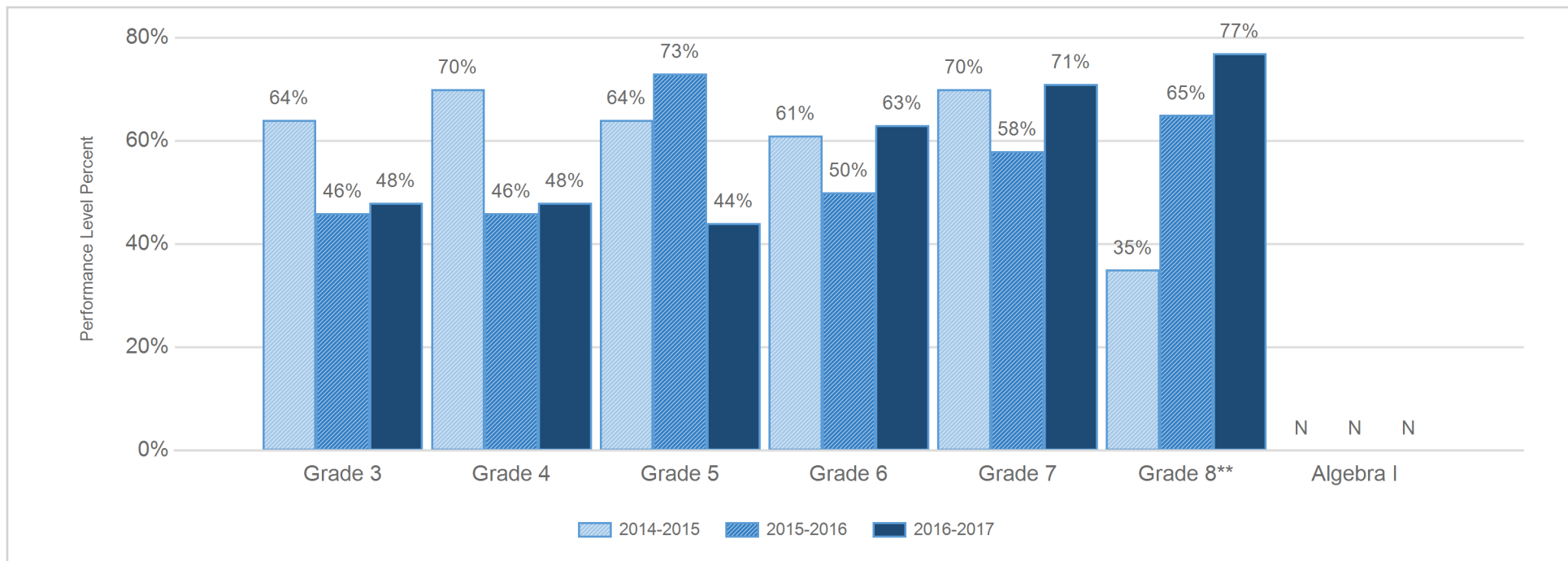

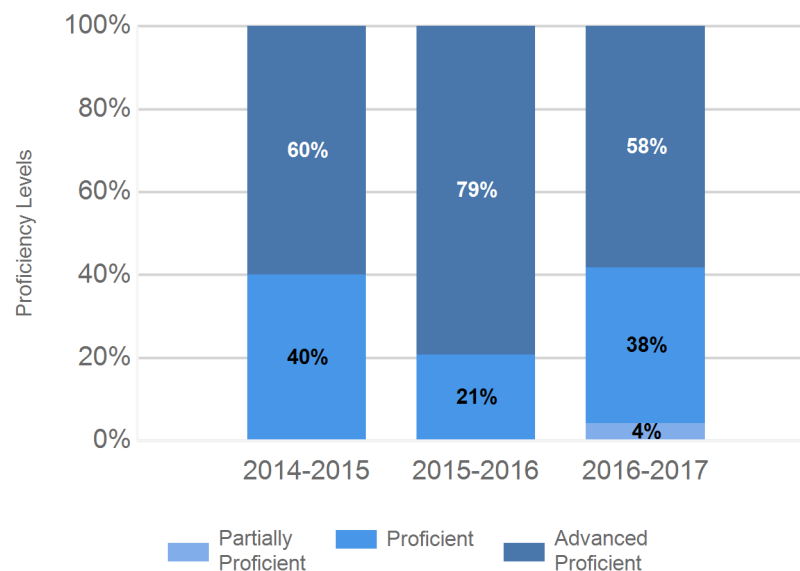

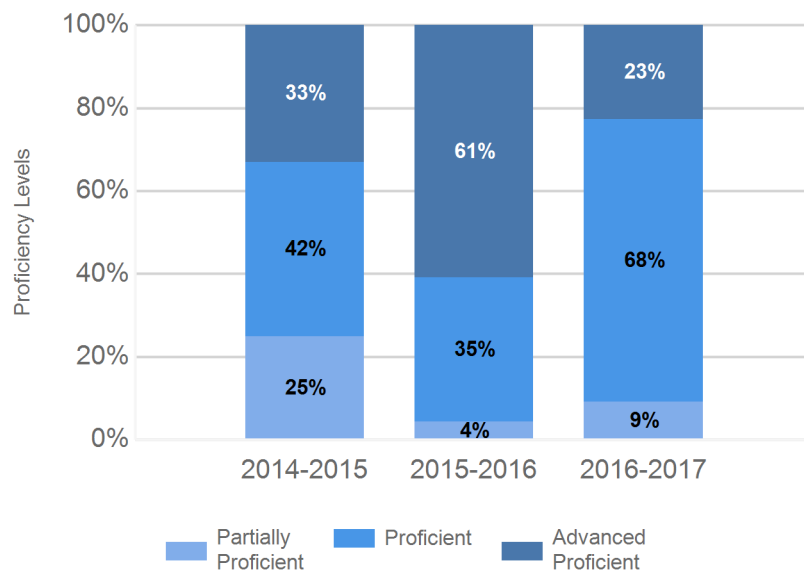

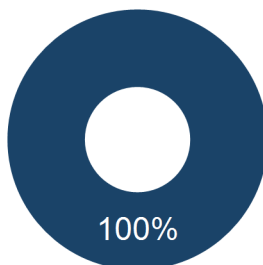

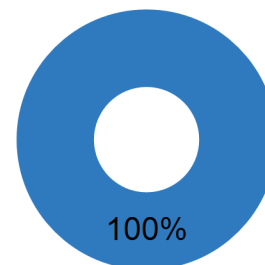

Students enrolled in one or more **visual and performing arts** classes

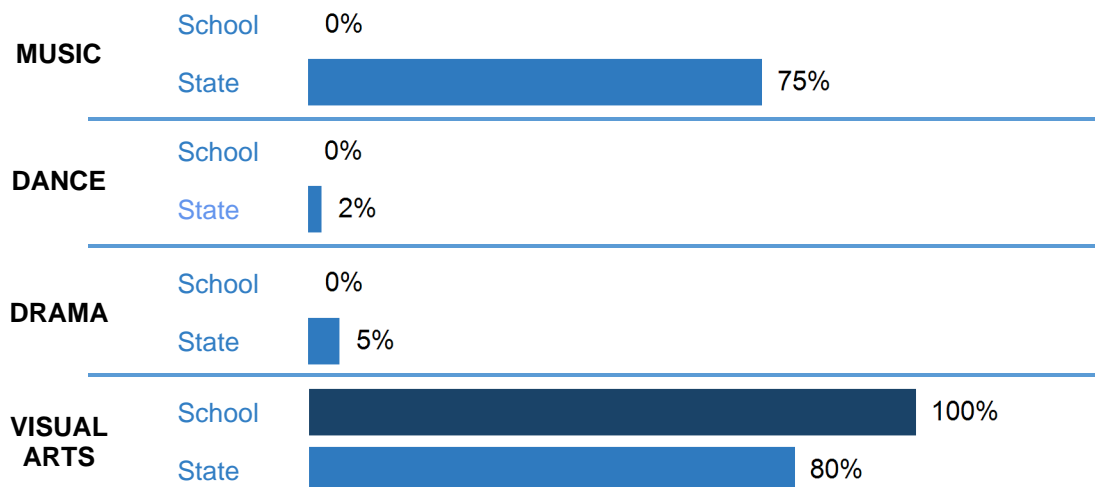

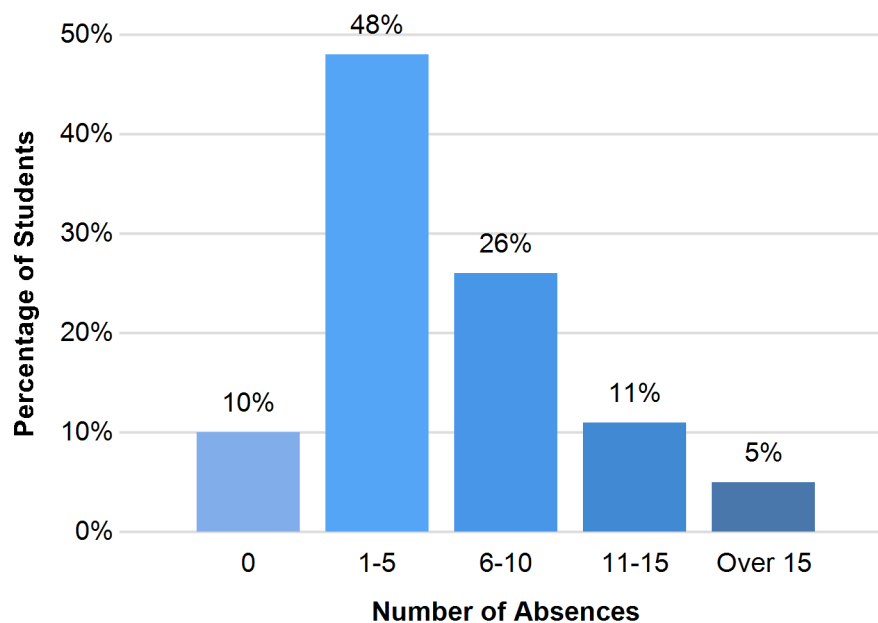

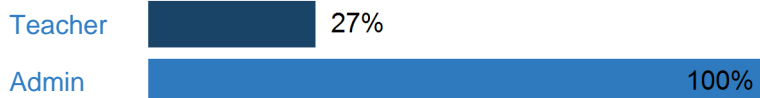

Other Information:

The school follows a uniform dress code policy that is distributed annually at registration to both parents and children. School begins at 8:30 a.m. and continues through 2:45 p.m. The length of the school year is 180 days. The school communicates with parents through a monthly calendar highlighting special events, by sending letters, emails, One Call Now announcements and through the school's website and Facebook page. The school's application for admission can be accessed through the website and is available in the school's main office. In December, a notice is sent home requesting the names of siblings who will be five years old by September 30th and who plan to attend the school. Also in December, a paid advertisement is placed in the Jersey Journal announcing the date, time, and location of the lottery and inviting families in the community to submit applications. The lottery is held on the second Monday evening in January, and it determines the new order of the waiting list in grades K-8 and/or acceptance for the upcoming kindergarten class. The school is equipped with cameras in every classroom, hallway, and outside around the perimeter of the building. School safety drills and fire drills are conducted each month.
